EuroBasket 2015

Prohibited items

The following items are prohibited (not allowed) in the venues of EuroBasket 2015. Persons carrying any of the items below will not be allowed into the venues and may be transferred to the local law enforcement representatives.

Items that are prohibited in the EuroBasket2015 venues are:

- Liquids, aerosols and gels in quantities greater than 100ml
- Any drinks (alcohol or not alcohol) (old: Alcohol, beer, soft drinks, water)
- Flasks, thermos
- Working tools
- Tents, placards, spray paint or any other item which could be used to demonstrate within the venue or sabotage property
- Glass bottles (Old: Glass bottles larger than 100ml (excluding medication contained in glass bottles)
- Motorcycle helmets
- Baby carriage
- More than one soft-sided bag of 25 litre capacity (you must be able to fit your bag under your seat)
- Walkie-talkies, phone jammers and radio scanners
- Personal/private wireless access points and 3G hubs (smart devices such as Android phones, iPhone and tablets are permitted inside venues, but must not be used as wireless access points to connect multiple devices)
- Laser pointers and strobe lights
- Items too large to be electronically screened
- Bicycles, folding bikes, roller-skates and skateboards
- Pets or animals (excluding service animals)
- All types of knives and bladed items, including pocket knives and knives carried as part of cultural dress
- Offensive weapons or implements such as bayonets, flick knives, extendable batons, sharpened combs, modified belt buckles and loose blades modified into weapons
- Items that resemble prohibited items such as replica guns or hoax explosive devices
- Personal protection sprays such as CS or pepper sprays

- Firearms and ammunition (including replicas, component parts or any device suspected to be a firearm)
- Any kind of flammable/explosive substances, liquids or gases or other flammable substances including but not limited to fireworks,
- Explosives, flares and smoke canisters
- Hazardous and toxic materials
- Controlled drugs, including substances which look like controlled drugs
- Large photographic and broadcast equipment over 30cm in length, including tripods and monopods. You cannot use photographic or broadcast equipment for commercial purposes unless you hold media accreditation
- Poles (i.e. flag poles) of hard material and/or longer than 1 meter
- Noisemakers such as hunting horns, air horns, klaxons, megaphones vuvuzelas and whistles
- Balls, rackets, Frisbees or similar objects or projectiles
- All other objects and substances that might endanger security, public health, public order and/or reputation of FIBA, Local Organising Committee and venue
- Paper rolls (WC paper; cash register paper, etc)

Restricted Items

In addition, there are items that are allowed inside the venues only as exceptions. Any such cases shall be agreed with the security manager of the respective venue.

Items that are restricted in EuroBasket 2015 venues are:

- Large flags (bigger than 1 metre x 2 metres) and banners
- Drums
- Oversized hats
- Large golf-style umbrellas
- Excessive amounts of food
- Baby Food

- Any objects or clothing bearing political, religious, racist, malicious, aggressive, agitating statements or overt commercial identification intended for 'ambush marketing'
- Flags of countries not participating in the EuroBasket

OVERSIZE FLAGS

In case of large flags and banners, the owner has to prove that it is not flammable, the owner shall bear a full responsibility by undersigning a specific legal form and prove his/her identity with valid passport or ID.

DRUMS

In case of drums, the owner shall prove that drums are not closed (one end must be open), none of the parts are flammable, and drums don't display any political or offensive messages. The owner of the drums shall bear full responsibility by undersigning a specific legal form and prove his/her identity with valid passport or ID.

BABY FOOD

If parents are attending the games with their babies, a special baby food is allowed into the venue if the amount does not exceed 1 litre per baby.

Check with staff if you're unsure about using an item inside venues, as some items may disrupt competition, obstruct the view of other spectators or create a safety hazard.
